# Certification

I understand that upon submitting this application, I have established a billing account in the name of the firm provided. In regard to Oswego County Department of Solid Waste Billing procedures, I understand that the total new balance on this account is due in full, no later than 12 noon on the last weekday of the month. Any outstanding balances will be charged interest at a rate of 2% (or a minimum charge of 50¢) per month, which will be applied to the new balance. If your account is past due 2 billing cycles or more, your privileges to use Oswego County Solid Waste Facilities will be revoked. Accounts past due 2 billing cycles or more will be sent to County Attorney for legal prosecution.

I certify that no hazardous or unacceptable wastes as identified by Local Law 2 of 2011, or wastes generated outside of Oswego County, will be delivered to any Oswego County solid waste disposal facility. The firm listed is in full compliance with the applicable federal and state statutes, rules and regulations pertaining to hazardous waste management and disposal. I am aware that there are significant penalties, including the possibility of fine/or imprisonment, for submitting false information.

The Oswego County Department of Solid Waste reserves the right to terminate this permit and use of all Oswego County operated solid waste disposal facilities, for any account that has not been paid in full or for any other reason as deemed appropriate by the Director of Solid Waste Programs or his designee.
