



# Oswego County Department of Solid Waste

## 2019 Residential Tipping Fee Sticker

### STICKER FACTS

- Must be an Oswego County Resident.
- Cost is \$185.00 (\$92.50 on or after July 1).
- All pink stickers are valid until Dec. 31, 2019.
- No Replacement Stickers will be given without a returned sticker.
- Residents must keep the sticker receipt for the term of the sticker.
- Hand Passes are no longer permissible.
- Stickers are non-transferable and non-refundable.
- Small business owners, including landlords, must use a Minor Hauler Permit.

### PROOF OF RESIDENCY

- Resident must submit proof of residency:
  - A valid NYS driver's license; **or**
  - Property deed or tax statement with additional proof of residency (i.e. utility bill, canceled mail); **or**
  - Rent receipt/lease agreement that shows Oswego County address, with additional proof of residency (i.e. utility bill, canceled mail).
- Proof of residency must show street address.
- *P.O. Box alone are not acceptable.*

### VEHICLE INFORMATION

- Vehicle must be present with current registration to purchaser's household address.
- Sticker may be issued to a vehicle with a temporary registration if insurance card and temporary registration information is the same.
- Sticker will not be placed on a vehicle registered to a business or address that is not the purchaser's household address.
- A Solid Waste employee must place, or witness the placement of the sticker on the designated vehicle while at the transfer station.

### ADDITIONAL STICKERS (\$10 PER VEHICLE)

- Resident must present proof of residency for computer verification of original sticker purchase.
- Additional vehicle must be present and resident must provide the additional vehicle registration.
- Additional vehicle must be registered to the same address as listed on the original receipt of purchase.

### SOLD, TRADED, DESTROYED OR JUNKED VEHICLES REPLACEMENT STICKERS (\$10 EACH)

- Residents must remove the sticker from the vehicle if the vehicle is sold, traded, junked, or destroyed and turn in to the scale attendant.  
***No replacement sticker will be issued without a returned sticker.***
- Resident must present proof of residency for computer verification of original receipt of purchase.
- Replacement vehicle must be present and resident must provide the replacement vehicle registration.
- Replacement vehicle must be registered to the same household address as listed on the original receipt of purchase.

### LOST OR STOLEN STICKER

- Sticker are the responsibility of the purchaser.
- If the sticker cannot be returned (except auto accident approved by DSW office) the resident will be charged a pro-rated price to replace the sticker.
- Residents must present the original receipt of purchase or proof of residency for computer verification of original purchase to receive a pro-rated replacement sticker.
- Sticker loss due to an auto accident may be evaluated on a case by case basis.
  - A copy of a police report; **or**
  - A written statement or report from the resident's insurance company verifying the accident.
  - Glass repair receipts.

## **BORROWING A VEHICLE**

- A borrowed vehicle is a vehicle that is not registered to the purchaser's address.
- Borrowing a vehicle and using a valid sticker receipt is intended for short term use only.
- Waste must be from the address of the sticker purchaser only.
- The sticker purchaser or household member must be present in the rented/borrowed vehicle at time of disposal.
- The sticker purchaser or household member must provide the valid sticker receipt and proof of residency at time of disposal.

## **CONSTRUCTION & DEMOLITION**

- Construction & Demolition waste (C&D) is generated by construction, demolition, remodeling, etc.
- Residents may dispose of small amounts of C&D on the sticker each visit to the transfer station.
- A small amount of C&D is equal to what the resident can physically carry from the vehicle to the pit in one trip.
- C&D may be bagged or loose.
- Any C&D in excess of what the resident can physically carry to the pit in one trip, must be weighed and the resident must pay \$135/ton, (\$10 minimum charge) at time of disposal.
- Residents may dispose of a small carpet on the sticker if the resident can physically carry it to the pit.
- Large carpets must be weighed and the resident must pay \$135/ton (\$10 minimum charge) at time of disposal.

## **TIRE DISPOSAL**

- Tires must be disposed of at \$135/ton (\$10 minimum charge) at time of disposal.

## **RESTRICTIONS**

- The sticker purchaser is responsible for the proper use of the sticker.
- Stickers may be used by the purchaser for waste generated by the purchaser's household only.
- Abuse of stickers can result in loss of disposal privileges and/or possible fines.
- It is not permitted to:
  - Haul wastes from other households using the sticker;
  - Haul business waste using the sticker;
  - Sticker is non-transferable to another resident, household or vehicle;
  - Deliver out-of-county waste to Oswego County Solid Waste Facilities.

## **FREQUENTLY ASKED QUESTIONS**

- Q. May I dispose of a boat (or camper, fiberglass truck cap, fiberglass swimming pool, etc.) using my sticker?
- A. *Residents must weigh and pay to dispose of these items.*
- Q. I recently bought a house to live in and I want to dispose of the garbage, C&D, and tires that were left on the property. Is this covered on my sticker?
- A. *Regular household garbage may be disposed of using a sticker. (Landlords are not permitted to use a sticker to clean out rental property.) Residents must weigh and pay for any bulk items, C&D, or tires from purchased property.*
- Q. A family member is recently deceased and the family needs to clean out the house. May we use a sticker?
- A. *If the deceased has a valid sticker, waste from that address would be covered on that sticker. If the deceased does not have a valid sticker, the individuals disposing of the waste would be required to weigh and pay.*
