WHEREAS, Central Services Position No. 168096101 – Computer Specialist is in the 2019 Adopted Budget at a salary of \$42,405 with associated Social Security of \$3,244 assigned to perform computer related functions at the Health Department; and

WHEREAS, it is necessary for that position to be in the Health Department's 2019 Adopted Budget in order to be eligible for Article 6 State Aid reimbursement.

Re: Maximizing state aid for IT position

BACKGROUND: The 2019 budget transferred the IT personnel of DSS and Health to the IT department for efficiency and central control. On February 8 in a meeting with our claiming and cost allocation consultants, Venesky, we were informed that State regulations allow DSS to continue claiming the IT staff for reimbursement under this new organizational structure, but do not allow the Health Department to claim reimbursement; the IT position must be in the Health Department's budget in order to receive reimbursement. Further, the Health Department's State Aid budget plan is due Feb 28th, so modifying the 2019 budget cannot wait for the March legislature meeting if the county wishes to maximize reimbursement.

PROPOSED SOLUTION: Adopt the attached budget modification moving the cost of one IT employee back to the Health Department.

FINANCIAL IMPACT: This action allows the Health Department to maximize Article 6 reimbursement, approximately \$12,000, while allowing the County to continue its plans to improve IT effectiveness.
