This APPLICATION does not guarantee receipt of a Certificate of Residence. Oswego County will only accept the Oswego County Certificate of Residence Application. Only a formal Certificate of Residence issued by Oswego County will be eligible for consideration for Community College Chargeback and said certificate is good for ONE YEAR from date of issuance unless any of the information on the provided application changes or does not match the billing information from the selected Community College. The student is responsible for providing the Certificate of Residence to the selected college.

INFORMATION FOR APPLICANTS:

Your completion of this form does not guarantee eligibility. There is no fee for a Certificate of Residence Application. Application must be completed using your full legal name. Nicknames are not accepted. All sections of this application must be legible and fully completed to be considered. Parent/Guardian information may be required for students under 18 years of age. It is recommended that you provide your phone number and/or e-mail address so we may expedite contacting you if there are any questions. This is a legal document and fraudulent applications will be prosecuted. It is advised that you keep a copy of the Official Certificate of Residence. Oswego County will NOT reissue or copy an issued Certificate of Residence. Records are purged each year and expired Certificate of Residences are properly destroyed.

Applicant must provide documentation substantiating Residence for a minimum of one year, proof of registration at college (either current class schedule or tuition bill) and meeting the requirements of Oswego County, even if this document is notarized. A government issued photo ID with your current address will be required. Documentation with PO Boxes is not accepted. Please contact the Oswego County Treasurer's Office if you have any questions on eligibility. If you are under 18 and/or financially dependent on a parent/legal guardian, their signature and proof of their residency in Oswego County must be provided with the application (usually their driver's license with street address).

The Certificate of Residence is effective for a period of one year from date of issuance, unless you change your address or change your name. If you change your address or name, a new application will be required. Oswego County verifies the addresses on the Community College bill to the approved Certificate of Residence addresses to confirm eligibility for payment of the bill presented by the College.

State Education Law, Sections 6301 and 6305 requires you to submit to the college of your choice a Certificate of Residence. If you fail to submit the Certificate of Residence you may be charged nonresident tuition. It is the student's responsibility to insure that the application is filed on time with the Oswego County Treasurer and that approved Certificates of Residence are provided to the selected college in a timely manner. The student is responsible for submitting the Certificate of Residence to the selected college. If approved, the student will receive two copies of the Official Certificate of Residence. One copy is for the student to keep as proof of receiving this document, the second copy is for the student to provide the selected college.

Certificates are issued for a specific college. One Certificate of Residence will be required for each college attended. Classes taken online at more than one college also require a Certificate of Residence for each college.

Maximum Certificate Issuance Schedule Based on College Start Date: No Exceptions Will Be Made

Eligible certificates will only be issued 60 days before college first day of class start date and 30 days after college first day of class start date. Date the application is signed by the student must be within the date range listed.
